CALL TO ORDER

Mr. Materne called the meeting to order at 7:01 PM. Pledge of Allegiance recited at 7:02pm.

CONCERNS AND COMPLAINTS

CURRENT ISSUES

- 1. Manitook Estates Administrative Consent Order No new information.
- 2. One Linden Lane Martel Mr. Choquette will check with Mr. Martel regarding the planting plan in the spring.
- 3. Map 63, Lot 12 Fairview Avenue Reuter forest cutting EO issued Ms. Bradley has no new information
- 4. Oakhill Beagle Club forest restoration and wildlife management plan Ms. Bradley sent an email to Mr. Tony Roderick regarding him not being able to attend the last meeting. He was asked to attend tonight's meeting. She never heard from him. He is violating the Conservation Restriction. Ms. Bradley suggested sending one more letter certified mail asking him to attend the next Conservation Commission meeting or the matter will be referred to town counsel.

PUBLIC HEARINGS & MEETINGS

1. <u>158 Anawan Street – Thomas Pelchat – ANRAD SE60-1070</u> – Mr. Brandon Faneuf was present on behalf of the applicant. He is before the commission presenting the ANRAD as requested. He began by stating he used the same line as Walter Hewitson and did not change anything. He walked his line and agreed with it. The only change is that Mr. Pelchat, under the valid order of conditions, had filled in the portions of the BVW that he was allotted under that order. Mr. Materne noted that due to snow on the ground the commission did not make a site visit. He questioned wetland flags 14 -21 that were removed from the plan. Mr. Faneuf stated those flags are on the abutter's property. There will be no work in that

area. Mr. Evans questioned the proposed 1300s.f. of fill and culvert. Mr. Faneuf confirmed the fill and culvert are already in.

Mr. Evans motioned to grant a continuance for Mr. Faneuf to the meeting on April 4, 2017.

Mr. Nicholson seconded the motion. Motion passed.

- 2. <u>Lindley Road field maintenance update</u> Brandon Hoderny stated the large field is complete and the 2nd field has been started and he will finish tomorrow. The valley on the right was left as is. The commission determined a gate should be installed 30'-40' into the Right of Way. Mr. Materne suggested possibly approaching the owners of the old Cork and Bottle to offer them a sum of money in exchange for allowing 2 or 3 parking spots for hikers. It may also bring business in to them.
