# REHOBOTH CONSERVATION COMMISSION Meeting Minutes – September 25, 2018

### CALL TO ORDER

Mr. Materne called the meeting to order at 7:00 PM with the pledge of allegiance.

#### **PUBLIC HEARINGS & MEETINGS**

- Ms. Rachel Smith from Otis Dyers office was present.
- Ms. Smith presented plans.
- Mr. Evans made a motion to close the public hearing.
- Mr. Nicholson seconded the motion. Motion passes.

# 2. 111 Summer Street - Babbitt - NOI - SE60-1112 / ANRAD SE60-1111

- Ms. Karen Patnaude of Earth Services Corp. was present.
- Ms. Patnaude presented plans.
- Mr. Materne asked where the slurry pit for the well was. Then stated it needs to be depicted on the plans.
- Mr. Choquette stated that from wetland flags A31 to A26 staked haybales with straw waddles need to be added.
- Mr. Materne stated that the test pits in the riparian zone need to be cleaned up. He felt that a fence should be put in at the limit of work.
- Mr. Nicholson stated that the commission has required fences from time to time on a case by case basis.
- Mr. Materne stated that he felt in this case that there needs to be a fence. There is no yard.

### 6. 79 Wheeler Street - Christian - ANRAD - SE60-1118

- Ms. Rachel Smith from Otis Dyers office was present.
- Ms. Smith presented plans.
- Mr. Materne stated that the driveway maybe partly in wetlands. Flag 58-67 are 30' from the beginning of the driveway. He also questioned if the cart path is jurisdictional. At flag 60-67 there are red maples that go through the wetlands. He asked if the commission felt this application should go out to a consultant for review of if the commission wanted to go back out to the site.
- Mr. Evans stated that it would be helpful to the commission to make a better decision if they had soil logs.
- Mr. Poyant asked when the old driveway was built and what its purpose was. If the commission had that information they may be able to decide as to if that area was jurisdictional.
- Ms. Smith stated that she would look into the driveway issue.
- The commission agreed that they would need soil logs to make a better decision.
- Ms. Smith requested a continuance until October 18, 2018.
- Mr. Evans made a motion to continue the public hearing until October 18, 2018.

### **CONCERNS & COMPLAINTS**

### 1. 75 Blanding Road - Rebello - Solar Panel in Wetlands

Mr. Louis Rebello was present on behalf of himself.

Mr. Materne stated he wanted the home owner to install a split rail fence. The fence would go from the second post closest to the house to the solar panels. Also, wants the fence line staked off.

Mr. Evans asked how long the home owner needed to complete the work required.

Mr. Rebello stated he was not sure.

Mr. Materne stated that the mowing around the solar panels will be allowed, and should continue so the area stays maintained.

### 2. 58 Winthrop Street - Harris - Debris in Wetlands

Mr. Poyant stated that the site is all cleaned as requested by the commission.

Mr. Habershaw made a motion to lift the Enforcement Order.

Mr. Choquette seconded the motion. Motion passes.

# 3. <u>248 Winthrop Street – Winthrop Propriety – Debris in Wetlands</u>

The property owner was present on behalf of himself.

Mr. Materne stated that work has been done on the property. There is fill beyond the limit of work. There is debris in the wetlands and a pile of gravel near the wetlands.

Mr. Nicholson stated that the debris will need to come out of the wetlands.

Mr. Habershaw asked if the commission should walk the site with the plans.

The property owner stated that G.T. excavating will be removing the debris.

Mr. Nicholson stated that the work should be done by October 14, 2018.

Mr. Evans asked the owner if he would be available on October 14, 20018 for a site walk with the commission.

The owner stated he would be on site that day.

# 4. 471 Tremont Street - Mello - Wetlands & Riverfront Alteration

Mr. Steve Mello was present on behalf of himself.

Mr. Materne stated that the commission had gone out to the property on Sunday September 23, 2018.

Mr. Mello showed the commission the seed mix that he had purchased at the commission's request.

Mr. Habershaw stated that the seed is turf seed, not a wetland seed mix. Wetland seed mix has a tag sewn into the bag to show what is in the bag as far as seeds.

Mr. Materne stated that there are flags missing. He then asked if the commission felt the flags should be replaced or if the property owner could use the plans in order to seed, when the correct wetland seed mix is purchased and approved by the commission.

Mr. Evans stated he was ok with the owner using the plan to seed.

Mr. Choquette stated that the equipment that is on the property needs to be moved to the front yard. The equipment is leaking all over the back-yard area.

# 5. 367 Anawan Street - Lillie May Realty - Debris in Wetlands

Mr. Materne stated that not much work has been done on this property.
