CALL TO ORDER

Mr. Materne called the meeting to order at 7:13 PM with the pledge of allegiance.

PUBLIC HEARINGS & MEETINGS

1. <u>582 Winthrop Street – RDA – Geiser</u>

Andrew Geiser was present on behalf of Dennis Geiser

Mr. Materne stated that the wetland line is accurate. Everything proposed is outside of the 50' buffer zone.

An abutter asked about zoning issues with the property.

Mr. Evans stated that the commission is not the appropriate board to comment on zoning.

Mr. Evans made a motion to issue a Negative 3 determination.

Mr. Nicholson seconded the motion. Motion passes.

2. <u>117 County Street – Farland – ANRAD – SE60-1114</u>

Mr. Materne stated that work had been done near the wetlands. Haybales have been installed. As far as correcting this issue the commission can have you file a NOI or treat it as a violation.

Mr. Evans stated that the front area of the home is not an issue for the commission. The south part of the property is the issue, there is a lot of watershed in that area. The issue is if significant water is going to be directed towards the wetlands without mitigation measures in place. This maybe something you can have

someone look at that is familiar with sheet flow and drainage. Work has been done without the required filing. You are not exactly sure of what you are going to do to fix the water issues on the property. The commission is going to need a more specific plan as to what you are going to do.

Mr. Materne ask Mr. Nicholson if they were to put fill in a depression would it fix the water problem.

Mr. Nicholson stated it would, but could also cause other water problems. You would need a drainage analysis done to show it won't directly affect abutters or wetlands.

Mr. Materne stated that there were no gutters on the house.

Mr. Ramey stated that they are trying to keep the swale and yard as it was.

Mr. Choquette stated that there isn't much foundation to grade off of. Maybe a dry well would help.

Mr. Materne stated that the property owners should probably hire an engineer, but that is up to the property owner.

Mr. Choquette stated that contour lines on the plan would be helpful.

Mr. Evans stated that they are going to need more information to come up with a Negative Determination.

Mr. Materne stated that the commission will still need to address the silt that is in the back of the property. There is erosion control to prevent silt going into the wetlands but the area will still need to be corrected. An erosion control matt could be put in place to prevent more siltation running into the haybales.

Mr. Ramey stated he could install it.

3.471 Tremont Street - Mello / Tarkin - Debris in Wetlands

Mr. Habershaw stated that the commission should visit the site in mid-May early June to ensure that the wetland seed mix has vegetated.

Mr. Mello stated that on the purchase and sales agreement, to whom ever purchase the property, that it will be notated that there are wetlands and riverfront on the property.

Mr. Habershaw stated that there should be 4 riverfront signs placed on the blue line to ensure that any one who purchases the property knows where the riverfront is. The signs should be place evenly apart from each other beginning at the start of the blue line to the end of the blue line. The home owner was advised that the signs need to be securely attached to the post. The deadline for installation of the signs is November 20, 2018.

4. 47 Pleasant Street - Concern

Mr. Choquette gave the commission an update in regards to this property. There was a new culvert put in place by the Highway Department. He stated he can only give an update to what is finished because all work is completed. On the home owner's property there is no protection near the inlet, erosion control needs to be put in place on the top of the loam line. There were also haybales on the property in a haphazard way near the pond, there needs to be straw waddles under the haybales to prevent siltation into the pond.

Mr. Materne requested Ms. Vilao compose a letter to inform the home owner that straw waddles need to be put in place as discussed above.
