CALL TO ORDER

Mr. Materne called the meeting to order at 7:00 PM with the pledge of allegiance.

PUBLIC HEARINGS

- 1. 159 Peck Street-RDA Guthrie
- Ms. Lynn Guthier was present on behalf of herself.
- Ms. Guthier present plans.
- Mr. Materne explained the reasons and differences of filing and RDA and a NOI. Confirms with the commission that the wetland line is accurate.

- Mr. Vincent Anarado was present on behalf of himself.

Mr. Anarado explained new updates to the berm and flat area. He stated his intentions yo use crushed stone to finish them.

Mr. Habershaw stated the importance of having the proper thickness of crushed stone on the flat area and where the crushed stone should be in the berm.

Mr. Kershaw stated the berm should be extended up towards the street to avoid any siltation going around the berm.

Mr. Habershaw stated the area around the berm should be seeded as well.

Mr. Anarado agreed with all recommendations. It will be done for next site walk.
