Kalifornia Karl (karaoke singer) is coming back on April 25<sup>th</sup>! This will be his 3<sup>rd</sup> return here at the Senior Center and he is well liked here. He will be paid out of Gifts & Bequests. We are working on getting a permit at a reduced rate discount through MA C.O.A. to show movies here at our Center on our Presentation Drop Screen in our Gert's Café. We also have a wish list for a nice electronic sign for the Café as well. We are still working on an electronic sign for out front.
