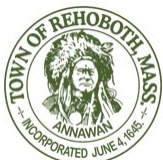

 - a. We voted to stay with the present timing of new members taking their seats on the School Committee
 - b. Consensus was to change recommendation for Quorum to be 8 members and a Positive Vote to be minimum 2/3 of all the weighted votes of all 10 members
 - c. We voted that if a Town pulled out their K-8 grades, that town will only be on the hook for capital costs associated with shared facilities (High School, central office, etc.) and their own K-8 facilities
 - d. Consensus was to review the RA every 5 years starting in January 2020 (?) and each 5 years thereafter. The RA review committee to be composed of 2 SC members, 2 administrators and 2 citizens appointed by Selectmen (1 from each town). The purpose of that RA Review Committee will be to recommend to the full S C to establish a RAAC...or not.
 - e. Major Capital Costs (necessitating bonds for financing) must be approved by both towns (for shared facilities) and by each town for their own k-8 facilities.
 - f. 4 different options for Statutory Assessment methodology were discussed and will be brought up again at the May 12th meeting (3 yr. rolling average of students, split by 3 major budget components(like we do today)), present method and splitting all Central Office 50/50, present method with splitting Central Office without Special Ed administration by 50/50)
 - g. Sue Lorenz list
 - h. Mac: other issues to resolve
