Councilwoman Hall stated that there is a factory at 67 Mechanic St. that needs to be rezoned but there is a contactor that wants to gut it and turn it into 55+ income based housing. She will keep people posted.

Chairperson Alexander thanked everyone for attending the meeting today.

He stated that he will make it to a Plymouth GCAC meeting in the next year.

He also invited everyone to the Strawberry Festival being held in North Attleboro on June 11<sup>th</sup>.
