On a motion made by Selectman Pimental, seconded by Selectman Vadnais, it was voted by roll call vote to enter Executive Session per MGL Chapter 30A, Section 21A (1) To discuss the reputation, character, physical condition or mental health, rather than professional competence, of an individual, or to discuss the discipline or dismissal of, or complaints or charges brought against, a public officer, employee, staff member or individual. The individual to be discussed in such executive session shall be notified in writing by the public body at least 48 hours prior to the proposed executive session; provided, however, that notification may be waived upon written agreement of the parties. A public body shall hold an open session if the individual involved requests that the session be open. If an executive session is held, such individual shall have the following rights:

i. to be present at such executive session during deliberations which involve that individual;

ii. to have counsel or a representative of his own choosing present and attending for the purpose of advising the individual and not for the purpose of active participation in the executive session;

iii. to speak on his own behalf; and

iv. to cause an independent record to be created of said executive session by audio-recording or transcription, at the individual's expense.

- (3) To discuss strategy with respect to collective bargaining or litigation if an open meeting may have a detrimental effect on the bargaining or litigating position of the public body and the chair so declares;
- (6) To consider the purchase, exchange, lease or value of real property if the chair declares that an open meeting may have a detrimental effect on the negotiating position of the public body;

I want to thank the hard work of all our officers on this case. Detective Ferreira and Detective Ramos led investigation and did an excellent job. Justice was served and thank you to all the officers.
- Chief Trombetta announced this morning Taunton Superior Court closed on a case that came to us on 1/20/12. The REPAC case where \$167,467.10 was stolen that lead to the indictment of Schagrin in March of 2013. I can't tell you the number of hours, by Detective Ramos, put on this case. We were able to locate and seize those funds. The case was closed on a plea agreement. I have a check for the town for \$117,560.00 the amount that Schagrin wrote out to himself. The rest of the money will be forth coming. Sergeant Ramos deserves a big pat on the back. We are lucky to have officers of this caliper on this force. A job well done. M. Costello thanks everyone for the support and a great outcome. The money will go back to Local Access where they can utilize the money.
- Jane Foster stated that picking up strange dogs (someone did in Norton and brought it to me)is very dangerous. Stop picking up dogs from other towns. The owner will get fined by the town because of leash laws, leave the dog there. To touch someone else's dog and put it in your car puts passengers in danger, leave the dog alone. # <u>Action Item (1) Police Chief Trombetta Re: 2015 Secure View Next Generation Grant & Request</u> for Reserve Fund Transfer

Chief Trombetta discussed grant application for the Secure View Next-Gen NUC Computer and requested a reserve fund transfer for \$4,999.00 to be transferred into Line 01203-52490 Software Maintenance/Upgrade to funds for the purchase of equipment and software.

Trombetta states that this is a great tool used to retrieve information off people's cell phones when needed in an investigation. Currently, we don't have the capability to do this in house so we have to send it out with the turnaround time being a couple of weeks to two months. We had an incident a couple of weeks ago in Beckwith School involving threats so we seized three phones through search warrants and those phones are still with the State Police. This makes our investigation stall. Year to date we have seized approximately thirty cell phones. Each phone we have seized required full or limited forensic processing from an outside agency. The cost of the equipment is approximately \$13,000.00 we are being offered a grant of \$4,999.00 which is a huge savings. I went to the IT Committee Meeting making sure that this model won't interfere with other systems we use or data we have. This unit actually retrieves deleted information which is useful and uses its' own computer system. Overall this is a very key piece of

equipment that we can use. Trombetta states that the deadline for this is tomorrow. The cost savings is \$7,391.00 for this unit so we would be looking for a reserve fund transfer for \$4,999.00. G. Schwall asked: when did the need for this come about? Trombetta: We have always had a need for this. G. Schwall stated we were offered a State grant I did not see this on the list. Trombetta: I would not have taken the \$12,000.00 State Grant money to spend on this, but at a discounted fee I feel this is the time to get it. G. Schwall states from my research, this is not a grant underwritten by the government, but an item on sale and they are calling it a grant. Schwall asked Trombetta if he has talked to the local detective divisions (Brockton, Medford, Tiverton) that have received this equipment in 2014. JT.: no I have not. I have read what it provides and I feel that it will enhance our ability to perform out duties in investigations. I would respectfully ask the Board of Selectmen to approve this grant. G. Schwall asked if Trombetta has looked at any other competitive products? JT.: No but if you find out of the same price and as good as this one I will be willing to purchase it. Schwall mentioned that a review stated that this unit has a very low chance of retrieving deleted data and may have an \$1800 per year update charge. Trombetta stated the unit we will be purchasing will collect deleted data, its stated right in the description. I had Sergeant Todd, who is computer savvy, research and review this equipment because I am not computer savvy. S. Vadnais stated that Brady said one of your providers will not be offering this service anymore, where would you go. JT: to the State Police. We have also reached out to Swansea and Seekonk. Seekonk is applying for this grant for this piece of machinery also. There is an annual maintenance fee of \$1495.00. The upgrades for the first year are included.

On a motion made by Selectmen Pimental, seconded by Selectmen Vadnais it was voted to approve the grant to go forward to the Finance Committee All Vote 4-0 Selectmen Schwall- Nay

#### Action Item (2): Algonquin Gas

Jon Bonsall, on behalf of Algonquin Gas presented a power point presentation on the Access Northeast Project and discussed the possibility of locating a compressor station in North Rehoboth. Frank Gesner Project Manager for Land and Rights of Way for Algonquin Gas, Jim Lesgate Regional Director of Engineering Construction with Spectra Energy Algonquin Gas were also present.

Jon Bansall: Access Northeast Project has three primary project developers: Eversource Energy, National Grid, and Spectra Energy. Algonquin Gas Transmission has been operating in our region since 1953. It's regulated by the Federal and U.S. Department of Transportation. Algonquin does not own the gas it just transports it for their customers. **See Attached handout given by Algonquin gas:** 

There will be an open house in the first quarter of the year. They are in the process of buying 120 acres of land that they will access through Finnegans Way.

The actual sight will be 120 acres plus the 14 acres we already own off Tremont Street. The system will have two buildings at location. It does not affect any of the easements. The noise is 55 DBA ,24 hours a day. The pipeline is carbon steel and tested before put in. This new system will tie into the existing pipeline. G. Schwall: What does a compressor station do? Bonsall: They are located 50 miles apart and at these points pressure is added to pipe driven by turbine engines bringing pressure higher. It will move a greater volume of gas. Noise sounds like rushing water at the gates of entry. Building is insulated for sound. We have been operating for 60 years in New England with a tight safety criteria and with quality materials and the inspection process it thorough. We have a safe operating record. When someone is contracted to work around our sights we always have one of our workers present to oversee that safety is practiced. Ed Bertozzi approached bench concerned about Algonquin developing the rest of land for 100 houses and also the noise factor. Rehoboth has a noise ordinance of 50 DBA he believes. Algonquin assures him that they will not be developing houses and they will check on the noise ordinance being at property line.
