

Eligibility

Any registered voter may use this application to request a mail-in ballot for any election being held in 2020.

Completing the Application

- 1. Voter Information Provide your name, the address where you are registered to vote, and date of birth. Telephone number and e-mail address are optional.
- 2. Ballot Information Choose which election(s) in which you want to vote by mail. If you are voting by mail in the State Primary and you are Unenrolled (Independent), choose one party ballot. Also provide the address where you want the ballots mailed.
- 3. Assistance If you are assisting a voter in completing this application, complete this section.
- 4. Sign your name If you require assistance in signing the application, you may authorize someone to sign your name in your presence. That person must complete the assisting person's information in Section 3.

Submitting the Application

Send the completed application to the local election official at your city or town hall.

Applications can be mailed or hand-delivered. Applications may also be submitted electronically by fax or e-mail, as long as your signature is visible.

If you're applying for a State Primary ballot, this application must arrive at your local election office by **August 26**. For November 3 State Election ballots, the application must arrive by **October 28**.



Due to the COVID-19 Pandemic and Social Distancing Protocols the following changes have been made to the way the September 1 and November 3 Elections will be conducted.

WHO - All registered voters – Precincts 1, 2 & 3

WHAT - State Primary (September 1, 2020) & Presidential (November 3, 2020)

WHERE - All Three Precincts Will Vote at the Palmer River Elementary School

Pursuant to Section 1 of Chapter 45 of the Acts of 2020 and because of the State of Emergency declared by the Governor pursuant to executive order 591, Declaration of a State of Emergency to Respond to COVID-19, the Governor signing new legislation on

July 6^{th} relative to voting options in response to COVID and its implications on election administration, which were voted by the Board of Selectmen and approved by State

Elections

At its meeting on August 10, 2020, the Board of Selectmen voted to reduce the polling locations due to the COVID-19 Pandemic, State of Emergency and Social Distancing Protocols. Selectmen voted to designate Palmer River Elementary School (PRES) - Gymnasium, 326 Winthrop Street (Route 44) in Rehoboth, MA as the polling place for the Tuesday, September 1, 2020 - State Primary Election and Tuesday, November 3, 2020 - Presidential / State Election, and to set 7:00 AM - 8:00 PM as the hours the polling place shall remain open for in-person voting; and to take any other action as may be required to comply with guidance provided by Town Counsel and the Massachusetts Elections Division. Said motion is made in recognition of the extraordinary challenges of conducting an Election during a public health emergency.

FALL 2020 ELECTIONS – VOTER OPTIONS GUIDE

On July 6th the Governor signed new legislation - An Act relative to voting options in response to COVID. This legislation outlines 3 options for voting in the fall 2020 elections –

SELECTION OF BALLOT TYPES - PRIMARY ELECTION ONLY

In a primary election, a voter who is NOT registered in a political party (Unenrolled or commonly known as Independent) must specify the party ballot type of choice on the application to vote by mail or in person voting (early or on Election Day). We are unable to process applications for Unenrolled / Independent voters who do not select a party ballot type on their application. Unenrolled / Independent voters who select a party ballot type do not become registered in that party - they remain Unenrolled / Independent voters. Voters who are registered in one of the 4 political parties (Democrat, Republican, Green-Rainbow, Libertarian) **MUST** take that party ballot and are not given a choice of ballot type. VOTE ON ELECTION DAY- WHAT YOU NEED TO KNOW BEFORE YOU GO:

As per the 8-10-2020 Vote of the Board of Selectmen, all Elections for the remainder of 2020 (9-1-2020 and 11-3-2020) will be held at the Palmer River Elementary School Gymnasium – 326 Winthrop Street (Route 44). When you arrive at Palmer River, **PLEASE:** Do not enter through the main entrance of the school (front of the building). Voters will line up on the black top area, which is located before the playground around the side of the building towards the back. All voters must enter from the Gymnasium Handicapped Ramp Entrance. Voters will line up by precinct*, on the blacktop, social distancing six feet apart. Thank you, Rehoboth Highway Department, for helping us mark the social distancing lines at Palmer River. 

KNOW BEFORE YOU GO TO THE POLLS

- Please do NOT go to the POLLS if you are sick or have been exposed leading up to Election Day.
- Wear a Face Covering or One Will Be Provided.
- Hands Will Be Sanitized Prior To Entering Voting Area or Gloves Will Be Provided.
- Bring a Pen Blue or Black ink Sharpie or Paper Mate Flair (if you don't want to borrow one).
- Bring a Clip Board or Book to mark your ballot on (if you don't want to use a Voting Booth).
- **Bring an ID** in some cases voters will be required to show an ID.
- **Don't Touch Your Face** while at the polling location.
- Maintain Social Distancing keep 6 feet away from anyone not from your household.
- Keep your ballot dry and free from hand sanitizers to avoid tabulator issues.

VOTE BY MAIL

All registered voters qualify to vote by mail in the Fall 2020 Elections. On July 15th vote-by-mail application post cards, from the Secretary of the Commonwealth, were mailed to ALL registered voters who have not already applied to receive a vote by mail ballot by July 1st. If you did not receive a vote by mail postcard and have not filed to receive your September and/or November ballots by mail, we have included a mail-in ballot application behind the front and back cover of this mailer. Please complete, sign with a handwritten, not typed signature and either scan and e-mail to us at TownClerk@RehobothMA.gov, drop off in the drop box outside of Town Hall, 148 Peck Street, or mail to the Town Clerk's Office, 148 Peck Street. VERY MPORTANT - APPLY EARLY - to allow ample time for processing your application and for the postal services to deliver your ballot to you. For your information, any voter that has returned a vote by mail ballot (or voted early in person) cannot vote on Election Day. Best way to return your ballot is to place it in the Drop Box outside of Town Offices (148 Peck Street).

to track the status of their application as well as their ballot status (mailed / received back in our office). Please note that we anticipate a large volume of applications (there are over 9,500 voters in Rehoboth) and request you allow at least a week or so before checking the status of your application and allow a minimum of 7 business days to receive your ballot from the status date of mailing. The Rehoboth Post Office has been very good about expediting ballots mailed at the Rehoboth Post Office; however, if you do not mail your ballot from Rehoboth, it can take 7 or more days for us to receive your mailed ballot from outside of Rehoboth. Please DO NOT contact the Clerk's Office to check on your status until the recommended amount of time listed above has passed. RETURN OF VOTE BY MAIL BALLOTS

Mailed Ballots include a postage pre-paid return ballot envelope that is addressed to the Town Clerk's Office. You may return your ballot by mail (please see deadlines below) or hand deliver your ballot by placing it in the drop box outside of the Town Offices (deadline is close of polls on Election Day). Ballots CANNOT be returned to the polling location on Election Day - they must be returned to the Town Clerk's Office for processing.

Deadlines for Ballots to be Returned and Counted

- Primary Election All ballots must be received at Town Hall by 8:00 PM on September 1st
- November Election
 - o Ballots returned in the drop box must be received by **8:00 PM** on **November 3rd**.
 - o Ballots <u>returned by mail</u> must be **postmarked by November 3rd** AND received by the Town Clerk by **5:00 PM on November 6th**.
- Please note that US Postal delivery services (outside of Rehoboth) are not consistent and can range from 3 to 11 days. We recommend voters return their ballots in the drop box outside of the town offices by 8:00 PM on Election Day to ensure it arrives back to us in time to count.

VOTE EARLY IN PERSON

Early Voting in person will be available for the fall 2020 elections. An application is not required to vote early in person...just show up and vote!

Vote "In-Person" on Election Day – As already stated, the Board of Selectmen voted that due to the COVID-19 Pandemic, State of Emergency and Social Distancing Protocols, all Elections for the remainder of 2020 (9-1-2020 and 11-3-2020) will be held at the Palmer River Elementary School Gymnasium – 326 Winthrop Street (Route 44). **Please do NOT go to the POLLS if you are sick or have been exposed to the virus leading up to Election Day.** Instead please call our office 508-252-6502 for voting options from home.

EARLY VOTING (by mail or in person) Frequently Asked Questions:

If I applied for a vote by mail ballot can I appear to vote "in-person" at an early voting site or at the polls on Election Day?

If your vote by mail <u>ballot has not been received back</u> to the Town Clerk's Office – <u>YES</u>, you may still appear to vote in person at the polls on Election Day. <u>These voters will be required to complete additional paperwork and will need to show an ID</u>. Should your mail in ballot be received after you voted early "inperson" or at the polls on Election Day the mail in ballot will be rejected and will not be counted.

If a vote by mail <u>ballot has already been received back</u> by the Town Clerk's Office - <u>NO</u>. A returned vote by mail ballot is considered cast and you will not be eligible to vote by mail, early "in-person" or "in-person" at the polls on Election Day.

If I vote early "in-person" can I appear to vote "in-person" at the polls on Election Day?

<u>NO</u> - If you appeared to vote early "in-person" your ballot will be considered cast and you will not be eligible to vote by mail, or "in-person" at the polls on Election Day. Voting "In-Person" at the Polls after submitting an early ballot is prohibited as outlined in 950 CMR 4 7.19.

When & how is an early voter's ballot cast?

All vote by mail and early voting in person ballots will be opened and inserted into a tabulator before election day or fed through the tabulators at the polls on election day. These ballots will be kept secured, locked, and unexamined until the polls are closed on Election Day. More information on how Rehoboth intends to process these ballots will be available on the Town Website at https://www.town.rehoboth.ma.us/ after the Secretary of State provides regulations on processing ballots before Election Day.

SAVE TIME & AGGRAVATION - KNOW BEFORE YOU GO:

1. Am I a registered voter & what is my party enrollment?

The deadline to register to vote or change your party affiliation for the State Primary Election is **Saturday**, **August 22**nd. You may register to vote or change your party enrollment online at: www.registertovotema.com Unenrolled (independent) voters will need to choose which primary ballot type they want to vote on. Voters who are registered in a particular party (Democrat, Republican, Green-Rainbow, Libertarian) MUST take that party ballot type — "verify your party enrollment" at

(https://www.sec.state.ma.us/VoterRegistrationSearch/MyVoterRegStatus.aspx) or "change your party enrollment" (https://www.sec.state.ma.us/OVR/) by the voter registration deadline.

2. Is my voter status "active"?

Per state law, voters must return their signed street list census forms annually to the Town Clerk's office to maintain an active voter status. **Inactive voters are still eligible to vote** but will be required to complete additional forms and show an ID at the polls in order to vote. Voters who appear as inactive can change their status to active by emailing a completed <u>census form</u> to <u>TownClerk@RehobothMA.gov</u> before **Monday, June 22nd** to avoid the longer check in process at the polls. **Check your <u>voter status</u> online at** https://www.sec.state.ma.us/VoterRegistrationSearch/MyVoterRegStatus.aspx.

3. What is my voting **Precinct**?

Voters are strongly encouraged to know what precinct they will be voting in before arriving at the polls. A greeter who will be managing the lines and providing entrance authorization to maximize social distancing within the polls will have the ability to look up your precinct – but this will likely slow down lines at the polls. **Check your precinct online** at https://www.sec.state.ma.us/wheredoivotema/bal/MyElectionInfo.aspx

4. What will I be voting on?

Our commitment is to keep voters and election workers safe:

- Voting Booths will be cleaned throughout the day.
- Unused or sanitized pens will be provided to those who need to borrow one.
- Hand sanitizer will be provided at the entrance and exit points.

Remember, due to social distancing protocols, if you don't want to wait in line outside in the elements, please consider voting by mail-in ballot and vote in the convenience and safety of your home.

Massachusetts Official Mail-In Voter Registration Form

How to use this form

- 1. Confirm your citizenship.
- 2. Print your name: last name, first name, middle name or initial.
- 3. Print your former name, if applicable.
- 4. Print the address where you live now: number and street name or rural route number and box number (do not provide a post office box number), apartment number, city or town and full zip code. Use the map^{*} at right if you cannot otherwise identify your address.
- Print the address where you receive all your mail, if it is different from the address entered on #4.
- 6. Print your date of birth: month, day and year. If you are 16 or 17 years old, you will be pre-registered until you are old enough to vote. You will be notified by mail when you become eligible to vote.
- 7. Federal law requires that you provide your driver's license number to register to vote. If you do not have a current and valid Massachusetts driver's license, you must provide the last four digits of your social security number. If you have neither, you must write "none" in the box.
- 8. It is optional to provide your telephone number. If you include your telephone number and do not check "unlisted" it will be a public record.
- 9. Check a party, 'no party' or print a political designation (not a party).
- 10. Print the address where you were last registered to vote.
- 11. If a person is helping you because you are physically unable to sign this form, that assisting person must print his or her name and address and has the option to print his or her telephone number.
- 12. Read the oath.
- 13. Print today's date.
- 14. Sign your name.

This form may be mailed or band-delivered to your city or town ball. If mailed, fold the form, tape it closed, place a first class stamp on it, print your city or town name and zip code for that city or town ball and drop into any mailbox.



You can use this form to:

- register or pre-register to vote in Massachusetts; and/or
- update your name, address, and political party.

To register or pre-register to vote in Massachusetts you must:

- BE A U.S. CITIZEN; and
- · be a Massachusetts resident; and
- be at least 16 years old.

Penalty for Illegal Registration: Fine of not more than \$10,000 or imprisonment for not more than five years or both.

-Massachusetts General Laws, chapter 56 section 8.

Identification To Be Provided

Section 7 requires you to include your driver's license number or the last 4 digits of your social security number on this application. This information will be verified through the Registry of Motor Vehicles and the Commissioner of Social Security. If the information cannot be verified or you do not provide this information, you must provide identification either with this application or at your polling location when you go to vote. Sufficient identification includes a copy of a current and valid photo identification, current utility bill, bank statement, government check, paycheck or other government document showing your name and address.


