Citizens of Rehoboth

Contained in this Special Town Meeting warrant are two articles for your consideration. Although as private citizens each member of the Board of Selectman has a personal opinion as to whether or not you should pass or reject the articles contained herein, as a Board, we do not take a formal position on passage of either of these two articles, other than to say if you do opt to pass Article 1, then we ask you pass Article 2.

Article 1 originates from a citizen petition submitted for the May 2020 Annual Town Meeting by Rehoboth citizens just prior to the start of the COVID pandemic. The article was submitted in accordance with our town bylaws and MGL Chapter 39 Section 10, and as such the Board of Selectmen are obligated to place it on the warrant. After several pandemic-related delays (with the approval of the petitioners) we now present their article for you to act upon at a dedicated town meeting where it can receive the attention it deserves.

This article asks the residents if the town should exercise its contractual rights under Section IX of the Dighton-Rehoboth Regional School District Agreement to withdraw grades K-8 from the Regional School District.

Should you pass Article 1, an independently-elected Rehoboth K-8 school committee shall reassume control of grades K-8. This newly-elected school committee – not the Board of Selectmen, as some would have you believe – will be responsible for preparing the K-8 budget for your consideration and approval at our annual town meetings. It will handle oversight of the operation of the K-8 schools in Rehoboth and be responsible for collaboration with DESE to ensure all applicable laws and regulations are adhered to so the quality of education in our schools will not only be maintained but also improved. It will exercise other powers and responsibilities empowered to school committees under Massachusetts General Laws, such as the ability to hire a Superintendent or enter into a Superintendency Union if it so deems it appropriate.

Article 1 *does not* dissolve the Regional School District nor *de-regionalize* Rehoboth's schools from the District. It impacts grades K-8 *only*. Grades 9-12 would remain unaffected; they would continue to be part of the DR Regional School District under the control of the DR Regional School District's school committee.

The second article deals with a bylaw modification to create and elect a Rehoboth K-8 school committee. Since we do not currently have a separate K-8 school committee in Rehoboth, we need a bylaw amendment to create one. This article will only need to be acted upon should Article 1 pass. Should Article 1 fail to pass, Article 2 becomes a moot issue.

Should both articles pass, at the next April town election you will be asked to vote for five residents who will serve as the Rehoboth K-8 School Committee. Those new committee members will be responsible for overseeing the process of re-assuming local control over the Rehoboth K-8 schools by working with DESE and the Dighton-Rehoboth Regional School District administration.

These articles are extremely important to all residents as they will impact the future direction you wish to see our K-8 school system take in the years to come. We ask you take time from your busy schedule on August 6^{th} and please attend the special town meeting to make your voices on this important issue heard.

Greetings:

In the name of the Commonwealth of Massachusetts you are required to notify and warn the inhabitants of the Town aforesaid who are qualified to vote in Elections and Town Affairs, therein, to meet at Francis Farm-Museum Building, on Saturday, August 6, 2022 at 1:00 p.m. to act on the following **Special Town Meeting** articles:

ARTICLE 1: WITHDRAWAL OF GRADES K-EIGHT FROM DIGHTON-REHOBOTH REGIONAL SCHOOL DISTRICT

SUBMITTED BY: TOWN OF REHOBOTH PETITIONERS

To see if the Town will vote, pursuant to Section IX of the Dighton-Rehoboth Regional School District Agreement, to withdraw Grades K-Eight (8) from such agreement and for the Town to resume jurisdiction over the education of said grades K-8, subject to compliance with any and all requirements of such agreement and applicable laws; and provided further that any such withdrawal shall be subject to any required approvals of the Commonwealth's Department of Elementary and Secondary Education; and, further that the Selectboard shall be authorized to enter into agreements and to take any and all other actions as may be deemed necessary to effectuate such withdrawal.

ARTICLE 2: TO AMEND TOWN OF REHOBOTH GENERAL BYLAWS-CHAPTER A-ARTICLE III SECTION 1 AND SECTION 2.1 SUBMITTED BY: BOARD OF SELECTMEN

Contingent upon the passage of Article 1, to see if the Town will vote to amend its General Bylaws as follows:

By amending Section 1 of Article III of Chapter A by adding the following: "Five members of a K-8 School Committee, each with a term of three (3) years, provided that at the Committee's initial election at the 2023 annual election, one member shall be elected for a one-year term, two members shall be elected for a two-year term and two members shall be elected for a three-year term, with subsequent terms to be for three years for all members."

By amending Section 2.1 of Article III of Chapter A by replacing it with the following: "Duties of the K-8 School Committee. The K-8 School Committee shall govern grades K-8 of the Rehoboth schools and shall have all the powers and duties that school committees may have under the Massachusetts Constitution and the General Laws of the Commonwealth."

1. Am I a registered voter & what is my party enrollment?

Unenrolled (independent) voters will need to choose which primary ballot type they want to vote on. 2. Is my voter status "active"?

Per state law, voters must return their signed street list census forms annually to the Town Clerk's office to maintain an active voter status. Inactive voters are still eligible to vote but will be required to complete additional forms and show an ID at the polls in order to vote. Voters who appear as inactive can change their status to active by emailing a completed census form @



- 4. Sign your name If you can't sign your name, you may ask someone to sign your name in your presence.
