Doing this would open the pool of candidates – not just Rehoboth resident. Possible Appointed position – 3-year term; 1 year probation. After retirement, the Board would like Cheryl Gouveia to help, on occasion, with the department.

Town Meeting approval required and specifics were discussed.


