**BOARD OF SELECTMEN MEETING

EXECUTIVE SESSION MEETING MINUTES  
Town Hall-Board of Selectmen's Office  
148 Peck Street**

**Present:** Selectman Frederick "Skip" Vadnais, Selectman David, Perry, Jr., Selectman James Muri, Selectman George Solas; Selectman Michael Deignan, and Assistant Town Administrator Cindy McDonough

At 6:25 PM Chairman Vadnais called the meeting to order in open session, stating the first order of business is Executive Session.

On a motion made by Selectman J. Muri, seconded by Selectman D. Perry, it was voted to enter Executive Session at 6:25 p.m. pursuant to *MGL Chapter 30A, Section 21A (2) to conduct strategy sessions in preparation for negotiations with non-union personnel or to conduct collective bargaining sessions or contract negotiations with non-union personnel; (3) to discuss strategy with respect to collective bargaining or litigation if an open meeting may have a detrimental effect on the bargaining or litigating position of the public body and the chair so declares; (6) to consider the purchase, exchange, lease or value of real estate, if the chair declares that an open meeting may have a detrimental effect on the negotiating position of the public body.*

Chairman Vadnais so declares.


