Town Administrator's Report:

- Last week it seems we had a little bit of technical difficulties during our Regular Session, so I will re-announce the winners of the First Porch Decorating Contest-put on by the Town Events Committee

- In Person early voting will continue this week until Friday, October 30th at Noon. All voters that would like to vote during this time can visit the Town Hall and come through the back entrance. There will be greeters at the door to help everyone navigate through the process. The hours are as follows:

- Steve Silva from the COA Board reached out to our office and asked if we could put together a few proclamations for upcoming 90th Birthday Celebrations. Due to Covid-19, things will have to be done differently. They will be having a "Drive-By" on November 7th from Palmer River School. They would like to have at least one Selectman to join Steve Howitt in a police cruiser. They will begin to gather at 10 am and leave by 10:30 am. Which Selectman would like to join Rep Howitt? Dave Perry stepped forward for this.
- Town Nurse updated us that Rehoboth is in the "yellow" at 6.8 (average daily rate over 100K). Anything over 8 and we will become "red", as several surrounding towns are. We have to be vigilant, keep masked up and no large gatherings.

NEW BUSINESS:

It was not an easy decision, all 3 candidates qualified for the job.

Action Item #5: Vote to Approve Hawker & Peddler License

If the Homeowner would like to proceed, they can make an appointment to have a sales rep come to their home. A CORI check has been done and came back clear; the fee has been paid. We are waiting on the Worker's Comp Affidavit.

- Now we move to Phase 2, hope moves as well, waiting for National Grid to get pole in, waiting on document from engineer then can start the process to put the pole in, and we can start doing the electric.
- Will walk through soon with other Town Officials


Perry: none


