#### **DEPARTMENT HEAD REPORTS**

#### Selectmen's Reports:

#### Costello:

1. Received a letter regarding the Hornbine Road lines needing to be repainted

- 36 miles already done this year at a cost of \$216-\$480 per mile
- This year Attleboro- to Swansea on Route 118, as well as Tremont Street, plus side streets
- We try to even out the North% and South% to be painted
- Will re-do in spring, we have to hire out. Bids will go out
- 2. Received a request to look at the Route 6 intersection
  - After DOT review not feasible for street lights at this time
  - We will revisit issue as things have changed
  - G. Schwall working with Representative S. Howitt
- 3. Hickory Ridge Road- Received a letter from Mr. Roach regarding lowering the speed limit.
  - -We cannot just change speed limits
  - Must follow DOT process, through the State
  - Suggested to have a petition in hand
  - The current unmarked limit is 40 miles per hour
  - BOS suggest to bring up at next Annual Town Meeting as bylaw change to 35 miles per hour; last time at ATM it was voted down
  - G. Schwall will put into ATM folder for 2020
  - M. Costello will work with DOT to try to change Hickory Ridge Road limit

Vadnais: Legion project is almost completed.

- Some finish landscape left, spring 2020
- This project began because of concerns from the public
- Thank you to Kevin McBride engineer for his help
- We feel we have listened to all concerns, have made some corrections
- Highway department helped a lot

#### Schwall:

- -We would like to reiterate to the School Committee that we urge the School Committee to accept the appropriation that was voted on at the Annual Town Meeting in May, again in July, and most recently in the October Town Meeting.
- -Acceptance of the \$18 million is recommended by the Finance Committee and will prevent any future intervention on behalf of the State. It would be in the best interest for all.
- -Social media posting by School Committee member, regarding illegal meetings with Board of Selectmen and State Reps. Addressing State Reps, Town Hall reps and counsel met to go over "facts" to help us understand- statutory method and other questions. If you feel we have violated open meeting law, encourage you to file a complaint.

Muri: Absent.
