<u>Johnson:</u> 46 Almeida Rd- All dirt has been removed and it's returning back to normal. Lenny Mills & Bob Materne walked property on Saturday and it's backfilled at this point. About 400 truck loads of dirt have been removed.

<u>Mills:</u> Discussed CDL drivers and standard contract signed with paving <<<< Francis Street needs to be repaired after winter and they agreed to fix >>>>

Highway Dept is ready for winter and in good shape. Salt is ready. Building Dept (Facilities Maintenance) working on Radon, PFAS, with BOH Agent, Karl Drown and a multitude of other things. They are short staffed but not looking to hire anyone at this time- this department is also ready for snow storms.
