Action Item #1: Approval of Renewal Contract with Meals on Wheels

Linna Sherman, Director of the Senior Center is asking the Board to review the renewal contract with Meals on Wheels, and to approve and sign the contract.

Action Item #2: Vote to Approve "Side Letter of Agreement" for Travel Policy for the Police Department

G. Schwall motioned to reject side letter. Second by D. Perry. Vote 5-0.

Action Item #3: Vote to Approve Vehicle Donation for Police Department

Action Item #4: Vote to Approve Quotes for the Aluminum Decking for the Modular Building

Mike Costello has received 3 quotes for the decking (ramps and stairways) at the Police Department. There was also one quote for using pressure treated wood. However, he feels that using aluminum decking it will be more durable and last longer.
