### BOARD OF SELECTMEN MEETING TUESDAY, FEBRUARY 21, 2023 MEETING MINUTES FRANCIS FARM- FRANCIS HALL 27 FRANCIS FARM ROAD

<u>Present:</u> Selectman Frederick "Skip" Vadnais, Selectmen Michael Deignan, Selectman George Solas, Selectman Leonard Mills Jr., Selectman Robert Johnson II and Town Administrator Deborah Arruda.

#### **NEW BUSINESS:**

## Action Item (1): Vote to Amend Motion Made on 11/28/22 for the Anawan School Property Swap Between the TOR and the Rehoboth Housing Authority

On November 28<sup>th</sup>, the Board voted to acquire property from the Rehoboth Housing Authority in exchange for the Anawan School. The motion made needs to include more detail in order to process the paperwork for the Deed. The Town Counsel has provided the motion that needs to be made and it will need to be signed by the BOS.

G. Solas- I hereby move that the Board of Selectmen acquire, from the Rehoboth Housing Authority the land off Anawan Street, shown as parcel 46-5 on the Rehoboth Town Assessor Maps, including 6.08 acres more or less, as authorized pursuant to Article 10 of the May 14, 2022 Rehoboth Annual Town Meeting and further to authorize the Chair, Frederick Vadnais, Jr., to execute and enter into any and all documents necessary to effectuate the acquisition of said property;

And I hereby move that the Board of Selectmen convey, to the Rehoboth Housing Authority the land with the buildings thereon located at 51/55 Bay State Road consisting of approximately 5.41 acres, more or less, as shown as parcel 39-97 on the Rehoboth Town Assessor Maps as authorized pursuant to Article 10 of the May 14, 2022 Rehoboth Annual Town Meeting and further to authorize the Chair, Frederick Vadnais, Jr., to execute and enter into any and all documents necessary to effectuate the conveyance of said property. Second by M. Deignan. Vote 5-0.

### Action Item (2): Vote to Approve Fire Department Software Update Proposal and Allow the Fire Chief to Sign Proposal

The Fire Chief needs the approval of the Board to enter into an agreement with Locality Media, Inc, dba First Due. The current vendor's cost is going to be \$16,000.00 for FY24. The chief researched other vendors and would like to procure Locality for FY24 for \$8,550.00, with a one-time set up fee of \$1,000.00, for a total of \$9,550.00.

G. Solas- motion to approve software update with Locality Media, Inc. dba First Due for a total of \$9550 for FY24 and to allow the Fire Chief to sign agreement. Second by M. Deignan. Vote 5-0.

### Action Item (3): Vote to Approve the Request for a Reserve Fund Transfer for the Health and Human Services Department for a Total of \$305.00

Richard Panofsky is requesting that the Board approve a transfer of funds from the Reserve Fund Transfer account to 2 newly created lines in the HHS budget as follows:

\$142-Expense In-State Mileage (051770)

\$163-Expense-Meals (055850)

Total \$305

- G. Solas- motion to approve \$305.00 to be transferred from the RFT line into the appropriate accounts under the Health & Human Services budget. Second by R. Johnson. No vote.
- M. Deignan- it's premature to make this change if a decision has not been made on how we are going to fund. Table until known.
- M. Deignan- motion to table discussion until we know what direction we are going in, perhaps late April. Second by R. Johnson. Vote 5-0.

### Action Item (4): Vote to Approve Budget Amendment for \$7988.00 from COA PT Salary Line to Health and Human Services FT Salary

Richard Panofsky is requesting a budget amendment from the COA PT Salary Line (051140) to the FT Salary line (051110) in the Health & Human Health Service for a future hire.

G. Solas- motion to approve the Budget Amendment of \$7,988.00 from the COA PT salary line into the FT salary line, in the Health & Human Service budget. Second by M. Deignan. No vote.

Per Selectman Deignan, a budget amendment is not necessary because the budget is voted on (as a whole) at Town Meeting.

M. Deignan-motion to table for the purpose of defeat. Second by G. Solas. Vote 5-0.

### Action Item (5): Vote to Approve Memorandum of Agreement Between TOR and Rehoboth Ambulance Committee, Inc.

L. Mills- motion to approve the Memorandum of Agreement between the Town of Rehoboth and the Rehoboth Ambulance Committee, Inc., effective February 22, 2023, to March 1, 2024. Second by R. Johnson. Vote 5-0.

### Action Item (6): Vote to Approve COA Volunteers Jennifer Shallcross and Kaaren Silverman

# Action Item (7): Vote to Approve Steven Thomas as Mechanic for the Highway Dept.-Internal Posting Steven Thomas has filled in when necessary and is a perfect fit with his vast knowledge and experience. He has been highly recommended by Kevin Chace.

L. Mills- motion to approve the promotion of Steven Thomas to the Mechanic's position in the Highway Department, effective immediately. Second by R. Johnson. Vote 5-0.

Selectman Mills stated that this is not a new position it was Mike Viveiro's position – in-house posting which Steven applied for and is very qualified.

G. Solas- motion to approve the 2022 ABCC Annual Report for the amount of \$20,710.00. Second by M. Deignan. Vote 5-0.
