NEW BUSINESS:

Action Item #1 Coronavirus (COVID - 19) Taskforce Update

G. Schwall read the statement which included decisions made over the past few weeks and additional information of importance as received from local, state and federal agencies. As of today, there have been 31 positive cases reported in Rehoboth. COVID -19Task Force will be adding a financial team. It will include, M. Deignan, Finance Committee Chairman, C. Gouveia, Town Treasurer, R. Oliveira, Town Accountant, D. Arruda Interim Town Administrator, and G. Schwall, Chairman of the Board of Selectmen. We will be reviewing again Town Meeting date; it was extended to the end of June, 2020. In order for your vote to count at Town Meeting you must be present. Town Election has been postponed to Tuesday, June 30, 2020. There are two alternative ways to vote in person. You can do an Absentee Ballot, which must be received by the Town Clerk by June 30, 2020. Both of these must be received by the Town Clerk before the close of the poles on Election day.

D. Perry -There will be no Memorial Day Parade. There will be only a service. This is to keep our Veteran's safe.

M. Costello- Virtual learning will be in place until the end of the school year.

J. Muri- Overdue library books can be dropped off in the box outside the Blanding Library. The COA is still opened for anyone needing help. You can call Lina Sherman. Brad Marshall will meet you by appointment. Meals on Wheels is still running. Bristol Elders has given us permission to extend the program to seniors who are not part of the program.
