Action Item #2: 7:30PM Public Hearing: Application from Liberty Utilities for Roadway Utility Installation License

R.J. Ritchie, Jim Carey and John Amaral from Liberty Utilities present. Former New England Gas Company.

Powerpoint presentation: Discussed the advantages to natural gas and how many communities they service. Described the project on Spring Street and how the route will run. Safety was discussed. Meet all State and Federal requirements. The company works well with the building department, building inspectors and first responders.

Veronica Brinkley; Bay State Road: You mentioned first responders; What type of emergency would you anticipate? J.C. The smell of gas from a leak. V.B. There is no worry about explosions? J.M. Hopefully not. We keep everything safe and we have a very good track record. All the employees are trained to handle natural gas and keep the community safe.

Tish Vadnais: Why do we need gas in Rehoboth? J.M. The developer of the project contacted us for our service. T.V. Are you the same group that is trying to put gas in North Rehoboth? J.M. No, they are an interstate pipeline company, we are a local distribution company. T.V. Will the homeowners that you pass to get to Spring Street be able to tie into this gas line. J.M. Any of the abutters along the route could tie in.

Jeff Medeiros; Spring Street: There is no shoulder of the road so where will the line be going? J.A. We will be going right outside the pavement on the grass area. J.M. What kind of pressure will you be using to get the gas all the way up Spring Street? J.A. Max 60lbs per sq. in.

Carolyn Castiligi; Spring Street: I have a big tree in my front yard will it be cut down. S.V. Any tree bigger than 10" in diameter requires a public hearing to be removed. R.R. We take the least invasive route.

Joan Medeiros: How long will this project last? J.A. Approximately 3-4 weeks. We work from 7AM - 3:35PM.

- M. Costello: This is their first process of approval. They still need to see me about a road opening permit and there are some criteria they need to meet before receiving that permit. There are some spots on the roadways where you will have to go into the road and off the edge. I also want to mention if you are planning on putting stubs in for the abutters. They may not want to tie in right away, but once the road is paved there is a five-year moratorium.
- J. Muri: In the event there is a break, what is your turn around time to get to it? J.C. We are out there normally is 1 hour. We have personnel 24 hours a day. J.M: What is the approximate cost for this phase. J.A. Around \$250,000.00. J.M. How are you bonded in case the project falls through and the roads need to be repaired? J.A. We have performance bonds that are required through MA Law and the DPW and we also have insurance bonds.
- S. Pimental: Instead of digging up lawns, why not go along road edge. J.A. We like to keep minimal impact to the roadways.
- G. Schwall: Voiced to Company to reconsider using the roads vs. digging up abutters yards. R.R. We are willing to be responsive to your needs and work with you. G.S. Why not go through Swansea the other way. J.A. We would be going through private property. G.S. We should hire someone that can be the Clerk of the works and oversee project.
- S.V. What will you do if you disrupt someone's lawn and driveway. J.A. We will talk to home owner and restore it.
- D. Perry: Before issuing the Road Opening Permit M. Costello should do a walk through with the company and make sure everything is touched upon and the bond will not be released until everything is done to satisfaction. Will you be putting points at all the abutters in case they do decide to tie on? J.A. We can use a technology that will allow for that, but we usually don't do that unless we have the customer first. We will be sending letters out.

Tish Vadnais: Why not go up through Hornbine Road, it seems closer to project? J.A. There are no gas lines on Hornbine Road.

Anthony; Hornbine Road: Why are doing 6" at development then going to 4"? J.C. The developer called us for our service and there is an economical reason.

M. Costello: I would rather see the company go through the easement than into the street on 118, I don't care about Spring Street, we will be paying that soon.

Joan Medeiros: Where would the gas be pumped from. J.C. Our supply is in Swansea and Fall River. J.M. How much to tie into the service? Joseph Lopes: If you are within 100 feet there is no charge.

On a motion made by S. Pimental Second by D. Perry it was voted to close public hearing.

G. Schwall: When would the project begin? J.C. Most likely spring of next year.

S.V. We have 30 days to render a decision. J.M. I would like to speak with the Highway Superintendent in regards to surety of this project and who would be the Clerk of the Works.

Liberty Utilities: We cannot give you an answer as to who the Clerk of the Works would be because that is a cost that would be given to the Developer of the project. As soon as we find out what that cost would be and the Developer is willing to contribute to that extra cost, we would be in agreeance with a Clerk of the Works.

G. Schwall: I struggle with the extent of benefit to the Town residents. I believe it benefits one resident. Also, usefulness of said utility to the Town. We have gotten by 374 years without gas lines coming up our roads. I am not sure we need it at this time.

On a motion made by G. Schwall Second by S. Pimental it was voted to take this matter under advisement. All vote 5-0
