- ➤ Ted Ballard: regarding the Anawan School project, the Board of Selectmen had designated the Water Commission to be in charge of any water issues that come up. I asked Jay Talerman a few questions and I would like a formal vote from the Board of Selectmen. S.V. any water issues with the Anawan School would be shared with the Water Commission and you would review it and act on it if needed. On a motion made by J. Muri Second by G. Schwall it was voted to allow the Water Commission for input and can advise the ZBA on any water issues if they arise with the Anawan School Project. All Vote 5-0 S.V. asked T. Action Item #3: Discussion Re: Liberty Utilities Application for a Roadway Utility License

S.V. read: On 10/10/17 the Board of Selectmen held a Public Hearing on the application from Liberty Utilities for a Roadway Utility Installation License pursuant to "Town of Rehoboth General Bylaws Chapter J Access to Roadway Article II Utility Installation in the Roadway". S.V. read: The Board received comments from the public in attendance and closed the hearing. In accordance with our bylaws the Board of Selectmen must render a decision on the issuance of a license, with all terms and conditions contained therein, within thirty days of the closing of the public hearing. Thirty days from closing the hearing on 10/10/17 is Thursday, 11/9/17.
