Action Item #3: Rehoboth Ambulance Committee Vehicles

Reuben Fischman from Rehoboth Ambulance present.

Rehoboth Ambulance has submitted a request as follows:

To purchase ambulances back from the Town for \$1.00, and in so doing we will also take on responsibility for registering them with the State and insuring them. The Ambulance Committee had originally purchased these vehicles and "sold" them to the town for \$1.00. Of the two vehicles, still under the Town, one of them has been taken out of service as the Ambulance Committee purchased a new vehicle. The other vehicle is still in service. Due to procurement laws the Town is unable to sell ambulances to Rehoboth Ambulance Committee for \$1.00. The Town would have to put the ambulances out to bid. The Board of Selectmen will reach out to the State Representative Steve Howitt and Senator to look into legislation that will allow Rehoboth Ambulance to obtain these vehicles.

On a motion made by D. Perry Second by S. Vadnais it was voted to allow G. Schwall, as liaison, to work with Town Counsel on this matter. All Vote 3-0

The Rehoboth Ambulance Committee contract with the Town of Rehoboth is dated 2005. The Board of Selectmen will have a future discussion with Rehoboth Ambulance Committee to work on a new contract.
