DEPARTMENT HEAD REPORTS

2/27/17 Selectmen's Reports:

Vadnais: The Finance Committee representatives will be at the budget review meetings.

• I met with the Mayor of Attleboro and we jointly issued separate statements to Spectra. The city of Attleboro is still in communication with Spectra so that we do not lose our opportunities for input before permitting. We are making sure all concerns are met for safety, health and well-being of our community and the people. Town Counsel is working on adoption of an environmental bylaw that states that any commercial project to perform a comprehensive review by a certified provided putting emphasis on health issues at the owner's expense. It will be at the May meeting. The Mayor was notified of the cancellation by Spectra.

Schwall: The Finance Committee should be notified when there is a snow & ice deficit. The Highway Superintendent should notify the liaison of the Finance Committee to go over any deficit spending. M. Deignan stated that they do receive copies of the snow and ice deficit.

• Speaking for myself; I am very disappointed that we are not at the High School tonight meeting with Spectra. It is a sign of disrespect. I want to thank Dave and Skip for working hard to get other communities involved. I will be watching Spectra very closely.

Pimental: I think that we should get our State Representative or Senator Kennedy involved to be on notice so that we do not miss any important timelines for permits.

Perry: I have been doing a lot of running around feeling like I am getting nowhere. I met with Spectra Friday afternoon in my kitchen and they told me that they were cancelling the meeting for Monday. Dave read a letter stating why Spectra cancelled meeting; see attached. We, as a Board, have worked hard to put this meeting together.
