Town Administrator's Report:

- On Thursday, we did a walk-through of the old Anawan School with Dean Harrison of WDC, Jonathan Tambia from Dept. of Housing and Community Development, Skip Vadnais, Dave Perry and John Santos. We are hoping to get approval for the project to begin.
- Leeann Bradley of Conservation informed me that they have received \$15,000 to begin the process of updated the Town's Open Space and Recreation Plan. This is through the Community Compact Agreement and Leeann will be working with SRPEDD. The Board of Selectmen thanked Leeann Bradley and Helen Dennen.
- Last week there was a leak in the Ambulance bay of the Public Safety Building. The water leak damaged a lot of the medical supplies also damaging the electric system of the closets keeping them in the locked position. They will be getting an estimate for the damages.

Action Item #3: FY18 Budget Reviews

The Chief put in for four new patrolmen to the budget. The wages are higher meeting the negotiated contract. Trombetta: I met with Glatfelter for a 6-hour meeting regarding liability risk assessment.

- We are under staffed- hire more – this will reduce overtime, long shifts, tired employees
- Increasing training budget – includes Blue Line indoor firing range that is brought to the station for training in; scenario based shoot don't shoot, low light night fire, etc. two times a year.

Brady: We are hoping to get the 911 grant.
