Town Administrator's Report:

- I attended a scoping meeting for the Reed Street bridge at the Shad Factory with Mike Costello and nine Mass Highway engineers. They anticipate the bridge to be down in two years, may be sooner. They feel it will be an easy process.
- I did send out the Financial Summit Meeting Press Release, it is Thursday April 27, 2017 at 7PM at the Senior Center.

Action Item #1A: Discussion w/ Elected Officials Re: FY18 Budgets & Warrant Items

G. Schwall recused himself.

Present: Cheryl Gouveia; Town Collector & Treasurer/ Laura Schwall; Town Clerk

Cheryl went over her departments budget and asked for an increase in her salary, as well as an increase in Laura Schwall's salary. Cheryl and Laura did a surrounding towns salary survey.

S. Pimental stated the Town will lose good people if they are not compensated accordingly. The Board of Selectmen support the salary increase.

Action Item #2: Discussion with Fire Chief regarding Fire Alarm System at Anawan School Chief Barresi present.

The fire alarm has gone off nine times since January and it is believed to be the old wiring. Home & Commercial has given some options: disconnect everything; install 3 or 4 wireless detectors (Home & Commercial will do at no cost to the Town); hard wire heat detectors which would cost the Town \$1,500; or \$5,000 and redo the entire system. The Board and Chief Barresi agree to have Home & Commercial install wireless detectors.

On a motion made by S. Pimental Second by J. Muri it was voted to accept Home & Commercial to install wireless detectors in the Anawan School. All Vote 4-0

Chief Barresi will call them and also thank them. Chief Barresi will also keep monitoring the building.
