4/23/18 Selectmen's Reports:

Vadnais: Board of Assessors is keeping abatement for Valor Act at \$500. We received a letter regarding speed limits and stop signs, the Board is not going to move forward on this matter until we put forth a policy for stop signs. The Town meeting voted on speed limits and our Town is not deemed as thickly settled.

Schwall: The Public Safety Building has been without water and I approved replacement of the water tank that was installed today. Fire Station 3 has received a grant for a lighting project completing 60 lights to LED. The savings will be great. G. Schwall read email from Chief Barresi regarding project and also thanked all involved. Bill Maiorano of REMA has solicited MEMA for disaster relief funds and we will be seeking reimbursement for Fire Chiefs vehicle, that was damaged in the storm, as well.
