Action Item #3: Board of Selectmen Vacancy

Discussion regarding filling the position on the Board of Selectmen vacated by Mike Costello. The Board is not in favor of spending extra money to hold a special election. The Board of Selectmen feels that the four remaining members can do the job until Selectman Pimental's term is up in April 2017.

Action Item #4: Board of Selectmen/ Town Administrator

The Board discussed their involvement in Town Management and roles of the Board of Selectmen and Town Administrator. The Board agrees to continue with the same management technique that the Board and the Town Administrator have been practicing.

Selectmen Vadnais gives an update from the last RAAC meeting.

- Administrative function to be 50/50 giving back \$120,000 to Rehoboth not Alternative Method it is Statutory Method
- Alternative Method to be applied to the mandated minimum amount
- We would like an alternative method in agreement both towns need to agree
- We need to go back to the way it was we had the alternative method
- George Solas & Sue McBride discussed Alternative Method vs. Statutory and how net minimum can be divided
- We need to have a Statutory Method that is functional
- Should be based on population
- Take out of pocket expense and divide it by enrollment per Town
- We all pay for our K 8 and at High School apply the Wealth Formula
- We are subsidizing the K 8 in Dighton
- Let's get the agreement together send it to Desi, before Town Meeting, and get their opinion
- Add Central Office and District Wide split 50/50

On a motion made by S. Pimental Second by G. Schwall it was voted to form an agreement with Rehoboth and Dighton pay for their own K-8 with the High School having the Wealth Formula with Central Office and District Wide split 50/50 All Vote 2-0 (Skip abstained- he is on the RAAC)

5/16/16 Selectmen's Reports:

Vadnais: none

Schwall: Update from David House regarding solar systems at both the COA and Highway Department: thorough report would present to the Board but he is out of town for a while: time sensitive: we are not producing enough power from the Highway Department due to an invertor failure. It shorted out probably from a lightning strike. This reduces the power production by a full 3rd. It is no longer under warranty and to repair it is \$4,500. D. House is recommending that we repair system. The COA has a similar issue (completely down) but is still under warranty. We should be monitoring the systems.

- ➤ Invite David House to speak in regards to monitoring systems options and COA system. On a motion made by G. Schwall Second by S. Pimental it was voted to expend \$4,500.00 out of Reserve Fund to repair Highway Departments Solar invertor. All Vote 3-0
 - I attended a Legislative Clamboil by Bristol County Fire Chiefs Association as the Fire Chiefs guest at Seekonk Rod & Gun Club. I was impressed by the Chiefs and the respect that the Rehoboth fire department has for their peers. Steve Howitt was present. I was surprised to hear that there are no fire services funding from the State.
 - There are some containers at station 3 for training purposes.
 - I want to recognize the Garden Club. They held a fundraiser on Saturday at the Goff Hall. They also do a lot of work throughout the Town.
