Open Forum:

Tish Vadnais: Asked about the 375th fund raising. Nothing was mentioned on how much was raised.

• M. Costello- They raised \$2600.

Farmers Market was a big success and had a great turnout.

I have had a handful of people come to me telling me that the BOS is standing behind the Proposition 2-1/2. One member specifically said they were "for it." And people are saying that this one person is speaking for the entire Board.

- ➤ J. Muri Board is not taking an official stance on the override. Our function is informational only. As a citizen myself, I have not made up my mind.
- ➤ M. Costello I spoke at the School Committee Meeting and made it VERY clear that I was speaking for myself, ONE member only. I do support the override 100% because we need it for the Town not just for the schools!
- D. Perry We are here just to inform the public, to help them make their own decision.
- ➤ M. Deignan There is miss information on social media and people should NOT be getting their answers from there. If you want answers to your questions you need to speak to the appropriate departments, whether it be on the override, effects on your taxes, the process, etc. Contact the experts, BOS, Accessors, Treasurer, and questions on school budget you should call Dr Azar.

NEW BUSINESS:

Action Item #1: Interview of Candidate for Position of Town Planner/Conservation Agent

Vote for appointing candidate for the position of Town Planner/Conservation Agent

- D. Scanlon Andrew Poyant was one of the best candidates out of the 6-7 that we interviewed
 - References spoke highly of Andrew
 - Very qualified for Conservation
 - Eagerness to learn the job of Town Planner
- J. Muri Clearly you know Conservation based on your resume, how well do you know Planning?
 - What do you know pertaining to Mass Laws?
 - What would you do?

Andrew – I have a rough idea of what goes into Planning. I was grouped with planners in my past work experiences. I worked with disaster relief recovery – Disaster Mitigation with FEMA. I currently cover a large portion of the U.S. (Ecology & Wild Life). I learn new regulations all the time, have a basic understanding of what it takes. I can read plans, worked with many application processes that may be similar to what is used in Rehoboth.

J. Muri – You work for CDM and you deal with many engineers. Do you feel confident enough to deal with all other types of engineers?

Andrew – Many times I am the translator between engineering and the public. Yes, I feel very confident with speaking to the public and engineers.

J. Muri – Currently you devote your time to one large project at a time. Will you be able to work on multiple projects at a time?

Andrew – Yes. Have worked on multiple projects in the past and currently.

- D. Perry Very impressed with you, coworkers' feedback and references' feedback.
 - Seems you have great people skills, which is very important in our Town
 - Very strong background in Conservation
 - Overall you are very knowledgeable in what you do

M. Costello – I know you have worked with 14-15 counties in MA, are you well aware of DEP?

Andrew – Even though I live in RI, the state that I'm most familiar with is MA.

M. Costello – What did you do in Brazil?

Andrew - Studied Bio Diversity & Natural Resources. Did an internship and worked with forest, worked with kids teaching them about conservation issues, worked with wildlife sanctuary

M. Costello – Although you are strong in Conservation, I'm hoping more things will get done in Planning; I was on the board. Are you able to devote 4 nights a month to attend 4 meetings (2 for Planning & 2 for Conservation)?

Andrew - Yes.

- M. Costello You will have a part-time assistant that will help with both areas. Will you be able to coordinate the workload between both areas?
 - You have a great background
 - Hoping you catch on to Planning quickly-biggest part is learning State Regulations

Andrew – Intrigued to learn Planning & want to always learn more.

G. Schwall – Thank you to the committee members for all the work they did for this interview process. Thank you to Dave for a great summary and thank you Helen.

I have nothing for you on the Conservation or Planning side of this interview because that is not my expertise. But, I am thrilled you come from the "private sector," we need more people from the private sector because you learn things that are not taught in the "public sector." So, please do not lose what you have learned.

What will be your biggest challenge working in for the public sector?

Andrew – Not sure, but I'm looking forward to a set schedule.

- S. Vadnais You have an impressive Tech background and degrees. Do you have the ability to apply that knowledge into your profession?
 - Your references speak highly of your ability to communicate. I saw that tonight & it was very good.
 - I like your poise. We all threw a lot of questions at you and you did well.
 - You have the ability to fit in—Communication is your best value.
- J. Muri Assuming you get the job, you will NEED to know the following:
 - 1) Be very familiar with sub-division law in Rehoboth
 - 2) Work well in our environment
 - Set up own schedule
 - Agenda
 - Determine workload for the day/week
 - Acting manager for both departments
 - 3) New GIS Software-talent with using program

Keep current agreement as is and pay library on a month to month basis until issues are resolved. Payment is 1/12 for the library and we will keep to that. If override does not pass & we go to a tent meeting, everything will be on the table and it will be devasting.
- ➤ Maureen Whittemore Pond Street, serve on Board of Trustees on Antiquarian Society if override passes will the library get the difference between FY18 & FY19?
- G. Schwall Yes.
- ➤ M. Costello School has made drastic cuts already and need to be careful and watch over spending. I withdraw my previous motion.
 - M. Costello motion to hold off signing agreement until after 7/17 Override vote & pay one twelfth of FY18 budget on a month to month basis. Second by, J. Muri. Vote 5-0.

Costello: Helen – Please keep me updated on Reynolds Ave sub-station, very important.

- Paving will be going on Wed/Thurs/Fri and roads will be closed at Blanding Rd and Miller St.
- I received a complaint from a resident on Winthrop street that their neighbor has a lot of trash, clutter, debris, etc. spread out on their property. I'm awaiting pictures that were taken before moving forward. There is a Class II license at location, they have sold junk at the location but do not have a dealer license. Building Commissioner needs to deal with violations; illegal apartment as well. There has also been illegal burning at the location and the fire department has been called out
- S. Vadnais Keep this on next week's agenda so we can revisit it. Make all appropriate departments aware of the situation, Building Dept, Fire Dept, BOH and have them get a report done on what actions have been taken. We need to make sure ALL businesses are following the Law.
