1.0) Executive Session: : At 6:00p.m. G. Schwall made a motion to enter into Executive Session,2nd by D. Perry, pursuant to Massachusetts General Law, Chapter 30A, and Section 21; (1) To discuss the reputation, character, physical condition or mental health, rather than professional competence, of an individual, or to discuss the discipline or dismissal of, or complaints or charges brought against, a public officer, employee, staff member or individual.

The individual to be discussed in such executive session shall be notified in writing by the public body at least 48 hours prior to the proposed executive session; provided, however, that notification may be waived upon written agreement of the parties. A public body shall hold an open session if the individual involved requests that the session be open. If an executive session is held, such individual shall have the following rights:

- i. to be present at such executive session during deliberations which involve that individual;
- ii. to have counsel or a representative of his/her own choosing present and attending for the purpose of advising the individual and not for the purpose of active participation in the executive session;
- iii. to speak on his/her own behalf; and
- iv. to cause an independent record to be created of said executive session by audiorecording or transcription, at the individual's expense.
- (3) discuss strategy with respect to collective bargaining or litigation if an open meeting may have a detrimental effect on the bargaining or litigating position of the public body and the chair so declares*

 - Project is currently at 59% complete with a project completion date of April 2017

4.0) NEW BUSINESS: Action Item #1: Public Hearing: Personal Kennel Permit

On a motion made by S. Pimental Second by G. Schwall it was voted to enter into public hearing. Roll call: Pimental-aye; Schwall-aye; Perry-aye; Vadnais-aye

Robert & Judith Grant- requested permit for 10 dogs, all Labrador retrievers. Abutters were notified. Animal Control Officer & Zoning Officer have signed off on application.

Robert & Judith Grant explained that the dogs are for personal use only. Breeding and selling to private home owners. The Board of Selectmen reviewed the map of building (kennel) and fenced area. The building is over 50 feet away from any neighbor.

David Tavares: Abutter; Concerned houses are too close. He is concerned he will hear dogs barking. Does not hear the 5 dogs now but afraid that he will hear 10. He has a child with special needs who is afraid of dogs.

Barbara Link; 17 Willard Avenue; not a direct abutter; very concerned about the noise and the waste seeping into the ground. She is concerned about the preservation of agricultural viability. Asked about number of litters and if on concert slab. She is concerned about people coming in to see dogs and parking on road.

Patrick Gouveia: 8 Willard Ave; across the street. Just hears yelping at feeding time. Her daughter goes every day to play with puppies. The place is kept very clean. He has no problem with kennel. I know all my neighbors very well. If there is an issue, I feel just go over and talk to them. He would like to have the laws changed in regards to how the process is in applying for a kennel permit. He mentioned that the building was put up before they received the kennel permit. G.S.: On application there is a proposed structure check off. Applicants state that there was a lot of confusion in understanding application. In the future we will move ahead and vote on a proposed structure with a plan at hand.

G.S.: Conceptual plans have been made and there are large boards that will be put on easels displayed at Town Hall, Library and Senior Center. On the Town website there will be a section with all the information on project, and a calculator for residents to put in assessed value of

house for debt exclusion. We may put together a panel discussion with department heads and committee members regarding their needs and reasons why. We could hold a Special Town Meeting in February or late March so we would save money instead of having a Special Election. We could utilize our census mailing for advertising purposes. S.P.: Our Town Hall, Police and Fire Departments are dumps. People need to go in and see the buildings. D.P. The buildings are only going to deteriorate more with time. The Police Department holding cells are not in compliance. G.S.: If we do not build a new building, we will have to spend a significant amount of money to get these buildings and security systems up to date. The new design is functional and economically put together. This building is a 50 year building. We will be having the department head answering the questions about the building that pertains to them. S.V.: The Municipal Complex Committee will meet in September.

Patrick Gouveia: Put up information on Town scroll regarding Municipal Complex updates. Have a video walk through of buildings also. The Board of Selectmen feels that is a great idea.

DEPARTMENT HEAD REPORTS 7/11/16 Selectmen's Reports:

Vadnais: I would like the evaluation of the Assistant Town Administrator on the agenda for the next meeting. It is something the Board wants to address immediately.

- Rep. Howitt informed me that the \$50,000.00 State Budget for the COA is still there. We need to thank Timilty & Howitt. There is one more hurdle in September to go through.
- Next week will discuss and address the citizens who want us to take a position on the no tax issue. There is a letter from them in our packets and we will discuss that at our next meeting. They do recognize that we cannot take a stand on for or against because we represent everyone in the Town. We will also send a letter to our contact person in Attleboro letting them know that we will be discussing the tax issue.

Schwall: none Pimental: none

Perry: We need new trucks. We need to buy at least three trucks to get us by. They are \$173,000.00 each. We will use Chapter 90 money, we do have enough for three trucks. If we do a three year lease it is 3.7% interest. Chapter 90 will not let us buy the trucks unless we have enough in our account. D. Perry supplied the Board with pictures of trucks.

On a motion made by D. Perry Second by G. Schwall it was voted to procure three trucks, all season bodied, through lease using Chapter 90 money, with the specifications that I have given. Discussion: S.P. each truck is \$173,000.00 and we have enough to purchase 2 trucks out right. S. V.: We are going to purchase the new and trade the old vehicles. On a motion made by D. Perry Second by S. Pimental the vote was amended to state three trucks to be traded as equipped with plows and equipment to offset cost of new spreader and equipment and lease new trucks for three years. All Vote 4-0
